I understand that any breach of the undertaking shall amount to contempt of court and I shall be liable to a term of imprisonment.

I understand that any court order made on this application shall not affect the bank in exercising lien, right of set-off, charge, or pledge, etc. over the deposit in my above-mentioned account.

And lastly, I do solemnly, sincerely and truly affirm/swear that the contents of this my \*affirmation/affidavit are true.
